# Message from the Principal ......

Dear Merredin College Family,

In line with the latest Health advice current Term 2 arrangements have been reviewed with the following changes, from Week 7, Monday 8 June 2020:

- Parents/carers and visitors may come on to school sites to attend pre-arranged meetings and for drop-off and pick-up purposes. This is to a maximum of 100 people with physical distancing in mind. As such the college will return to normal pick-up and drop-off arrangements for primary aged students.
- Activities will be reintroduced with a maximum of 100 people indoors and 300 people in an outdoor setting including: assemblies, interschool sport, incursions, excursions, contact sport, PEAC, workplace learning and work experience.

With parents not being able to access the college we have noticed a significant increase in the development of independence skills especially in the early years. We strongly encourage parents to support the development of these new skills by allowing students to follow established routines, an example would be carrying and unpacking school bag and being responsible for their own belongings.

# Online Literacy & Numeracy Assessment (OLNA) Year 9

We have been advised by SCSA (School Curriculum Standard Authority) that schools will be provided with an additional OLNA sitting in 2020 for Year 9 students on an opt-in basis with the college opting in. In addition, this year, Year 9 students who achieved Band 8 or higher in the relevant Year 7 NAPLAN writing assessment will be considered to have met and prequalified for the writing standard. All Year 9 students will be required to also sit the Reading and Numeracy assessments. The Authority will provide further details regarding the additional opportunity for Year 9 students to sit the OLNA in future correspondence.

# 2020 Externally Set Tasks (EST's)

Schools have been advised we are required to administer the EST during weeks 7, 8 and 9 of Term 2, 2020 (8-26 June, 2020). The EST is compulsory for students enrolled in General courses and forms part of the schoolbased assessment and is included as a separate Assessment Type with a weighting of 15% across the pair of units. The EST will take 50 minutes and must be completed under standard test conditions.

# **2020 ATAR Course Examinations**

The Authority confirms that the 2020 ATAR course written examination period will go ahead as scheduled from 2 November 2020. The written examinations will be the same length of time, and in the same format, as indicated in the syllabuses for each course. Students can access the ATAR Exam schedule from the SCSA Website from Wednesday, 10 June 2020.

ATAR Physical Education Studies practical examinations will not go ahead as scheduled, for which details will be advised, after the Authority has completed further consultation.
